ORDINANCE NO. 2020-03

AN ORDINANCE IMPOSING A FINE FOR FAILING TO COMPLY WITH REQUIREMENTS OF BUILDING PERMITS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SHERMAN, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

<u>SECTION 1</u>: Whereas, the Village has encountered several instances when a property owner or a contractor has built a home or commercial building not in compliance with a building permit issued by the Village, usually by building the building outside the required setbacks or across the property lines.

<u>SECTION 2</u>: The Village Board has determined that a penalty should be imposed on both the property owner and contractor in the event buildings are constructed not in compliance with the terms of the building permit or the Village Code;

SECTION 3: Section 10-3-2 of the Village code is hereby amended with the addition of 10-3-2 (F) as follows:

F. In the event construction does not comply with the terms of the building permit issued hereunder, or in violation of Village Code, both the owner and if applicable general contractor shall be responsible for the payment of a fine in the amount of \$2500, payable to the Village. Any fine under this section must be paid prior to the issuance of a certificate of occupancy.

<u>SECTION 4.</u>: The Zoning Enforcement Officer is authorized to make appropriate changes to the Building Permit application so that owners and contractors will be aware of this provision at the time of the execution of the building permit application.

<u>SECTION 5</u>: This Ordinance is effective upon its passage and publication. The Clerk shall publish this Ordinance in pamphlet form.
