**ORDINANCE NO. 2022-19**

**AN ORDINANCE ESTABLISHING SALARIES  
FOR CERTAIN VILLAGE EMPLOYEES**

**WHEREAS**, the Village of Sherman ("Village") is a home rule municipality pursuant to Article VII, Section 6 of the constitution of the State of Illinois; and

**WHEREAS**, as part of its budget and planning process, and the adoption of same, the Village sets forth a salary schedule for its employees; and

**WHEREAS**, the corporate authorities of the Village desire to establish the salary schedule for Certain Village Employee as set forth in this Ordinance.

**NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Sherman, Illinois, as follows:**

**Section 1. Recitals.** The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2. Salary Schedule.** The salary schedule set forth in the attached Exhibit A shall be effective for the employees identified therein and shall be effective as of the dates listed.


**Section 3. Repeal.** All Ordinances or parts of Ordinances in with this Ordinance are hereby repealed insofar as they are in conflict with this Ordinance.

**Section 4. Severability.** If any provision of this Ordinance or its application to any person or under any circumstances is adjudged invalid, such adjudication shall not affect the validity of the Ordinance as a whole or of any portion not adjudged invalid.


**Section 5. Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law where indicated on the Attached Exhibit A.
