

Updates to Governor's Executive Order to Phase 3 State and Local Impact of Restrictions May 21, 2020 – Village of Sherman

BARS AND RESTAURANTS

With Phase 3, bars and restaurants will have the option to resume operations for outdoor seating in addition to curbside, carry out and delivery. Tables must be six feet apart and away from the sidewalks, masks and distancing measures for staff must continue to be followed, and other precautions and guidance will be issued by the Illinois Department of Public Health at www.dph.illinois.gov.

Sherman Impact. Ordinance requirements to purchase “Outdoor Café” permits have been suspended during this period. The Village encourages local bars and restaurants that wish to provide “outdoor seating” comply with the Governor’s order and implement guidelines as set forth by the IDPH to provide a safe environment to guests and employees.

OUTDOOR ACTIVITIES - PARKS

With the start of phase 3, all State parks will reopen on May 29. All concession will reopen as well under guidelines set for our retail and food service businesses in Phase 3. Illinois will permit the re-opening of indoor and outdoor tennis facilities with Illinois Department of Public Health (IDPH) safety precautions and capacity limits.

Sherman Impact. Sherman Parks have remained open with restrictions for outdoor recreation under the current Executive Order. Beginning May 29, the Village will open as follows:

Waldrop Park. Gates will be unlocked for visitor parking from Dawn to Dusk. Restrooms and Shelter will be open for public use. Sports fields will be open for public play and organized league play. Patrons and permittees are encouraged to conform with IDPH safety precautions to provide a safe environment. Reservations and permits are recommended. League play requires reservation. See below for more information.

Sherman Village Park. Restrooms will reopen for public use. Large Fire-Place Pavilion, Gazebo and smaller Shelters will be open. Gathering capacities and safety guidelines are encouraged to be followed as provide by IDPH and Governor’s Executive Order. Playground will remain closed per the Governor’s Executive order. Reservations are encouraged. See below for more information on reservations.

Other Parks Operated by Village. Other parks will remain open as usual.

Reservation & Permit Fees. Reservations to permit use of outdoor shelters, gazebo, sports fields and related areas are encouraged. Fees may apply. Permittees are provided priority use of permitted facilities. League play use at Waldrop Park for use of sports fields is required. Contact Village Hall

2020 Sherman Fireworks Spectacular & Events. The Village **WILL** hold its annual July 4th Fireworks Spectacular. The event will be held on Saturday, July 4. Events will resume in July as well. Announcements will be made via the Village Website, Facebook and posting at local Businesses/Sponsors.

OUTDOOR ACTIVITIES - GOLF COURSES

In Phase 3, golf courses can allow foursomes out on the same tee times. Carts will also be permitted with one person per cart, or one immediate household per cart.

Sherman Impact: The Rail Golf Course will be allowing open driving range and practice green, foursomes allowed, golf carts allowed, 10 minute tee times intervals, Pro Shop will be open for Merchandise, Food & Beverage allowed on course and patio seating is available. Call pro shop for tee times (217) 525-0365.

OUTDOOR ACTIVITIES – BOATING & CAMPING

With the new ten person gathering limit for all activities in Phase 3, boating or camping with up to ten people will be permitted.

OUTDOOR ACTIVITIES – OTHER RECREATIONS BUSINESSES

The state will be providing guidance on how other outdoor recreational businesses, such as driving ranges, outdoor shooting ranges, and paintball courses can safely open their doors in Phase 3.

HEALTH CLUBS, RETAIL, AND PERSONAL CARE SERVICES

In Phase 3, health clubs, gyms, and fitness studios can provide one-on-one personal training in indoor facilities and outdoor fitness classes of up to ten people.

Sherman Impact: Snap Fitness will be offering its fit camps at Sherman Village Park, one on one fitness and more. Contact Jill at (217) 381-4951 for details and operational hours.

Personal care services, like nail salons, tattoo shops, hair braiders, spas and barbershops, can open with IDPH safety precautions and capacity limits.

Sherman Impact: Local Hair and Nail Salons will reopen. See the attached list for details.

All retail stores can open their doors to in-person shopping with IDPH safety precautions and capacity levels in place.
