

RESOLUTION 2020-02

A RESOLUTION PROVIDING FOR THE LOCATION OF ADDITIONAL STOP SIGNS IN THE VILLAGE OF SHERMAN

WHEREAS, the Village of Sherman is authorized by the Illinois Vehicle Code, 625 ILCS 5/11-208, to regulate traffic by means of traffic control signs; and

WHEREAS, Title 7, Chapter 1, Section 1-1—5 of the Village Code provides the Village Board of Trustees may designate certain streets as stop streets and that said signs shall be posted at the appropriate locations indicating said stop streets; and

WHEREAS, the street known as Old Tipton School Road has become a high-speed area of vehicular traffic that threatens the life, safety and property of residents, families and visitors that needs to be calmed;

WHEREAS, it is recommended that stop signs be added to the intersection of Old Tipton School Road and Red Bud Run making it an all way stop and Old Tipton School Road and St. John's Drive making it an all way stop;

WHEREAS, the Corporate Authorities of the Village of Sherman find it in the best interest of the Village and necessary for the safety and welfare of the residents of the Village, to add stop signs as recommended at the location of this resolution;

NOW, THEREFORE, BE IT RESOLVED by the President and the Village of Sherman Board of Trustees authorize the President to execute the program and staff to carry out the program.
