Ordinance No. 19-11

AN ORDINANCE AUTHORIZING LITIGATION RELATED TO THE SHERMAN/WILLIAMSVILLE BIKE TRAIL

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SHERMAN, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

<u>SECTION 1</u>: Whereas, the Village has previously agreed to cooperate with the Village of Williamsville, IDOT and Ameren to develop the Sherman to Williamsville bike trail.

SECTION 2: Whereas, the parties have been negotiating with the owner of a parcel of real estate (Sangamon County Parcel number 07300153001) which is needed for use as the trail head at the North border of Sherman;

<u>SECTION 3</u>: Whereas, the parties need only approximately .38 acre to complete the project.

SECTION 4.: The parties have had the entire parcel and the small portion of the parcel appraised, but have been unable to come to an agreement for the transfer of the portion of the parcel at a price close to the appraised value;.

<u>SECTION 5</u>: It is necessary for the Village to obtain title to the portion of the property in order to complete the bike trail;

<u>SECTION 6</u>: The Village attorney is authorized to commence litigation to obtain title to the portion of land required for completion of the bike trail. This ordinance is effective upon passage.
