

Ordinance No. 22-15

**AN ORDINANCE AUTHORIZING CONTRACT FOR  
ADDITIONAL CAPITAL IMPROVEMENT PLAN 2022 PROJECT**

WHEREAS, the Village of Sherman has previously approved the advertising of bids for various projects within its Capital Improvement Plan;

WHEREAS, advertisement for bids for a project concerning improvements to the Village's roads was duly placed;

WHEREAS, on August 25, 2022 at 10:30 AM, Kuhn & Trello held a public bid opening for said project on behalf of the Village;

WHEREAS, upon review, of all bids, Kuhn & Trello determined Truman L. Flatt & Sons Co., Inc was the lowest responsible bidder for the project, and recommended the Village approve the project to Truman L Flatt & Sons Co., Inc. Flatt has commenced work on the project, and has determined that additional funds are necessary for some additional work on the village streets.

WHEREAS, it is economical to have Flatt do that additional work while they are already on site, and the necessary manpower and equipment are assigned to the Sherman work sites,

*NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SHERMAN, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** The Village Board has reviewed the proposal to do additional work on Brookside Glen not included in the initial Capital Improvement Plan, and approves the execution of a contract for additional work on Brookside Glen an amount not to exceed \$210,000.

**SECTION 2:** The Mayor is hereby authorized and empowered to execute said Contract with Truman L Flatt & Sons, Co., Inc. on behalf of the Village.

**SECTION 3:** This Ordinance is effective immediately.


