

RESOLUTION NO. 24-01

**A RESOLUTION AUTHORIZING THE SALE OF CERTAIN VEHICLES &
EQUIPMENT OF THE VILLAGE OF SHERMAN**

WHEREAS, the Village of Sherman, Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code, and

WHEREAS the corporate authorities of each municipality may pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities, with such fines or penalties as may be deemed proper; and

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/11-76-4, grants municipalities with a population less than 500,000, the authority to sell and dispose of personal property it determines, by a simple majority of the corporate authorities, to be no longer useful and necessary; and

WHEREAS, the Village of Sherman has vehicles and equipment that are no longer of use or necessary for the Village operations notably a 2007 Dodge Durango, 2004 Chevy Impala, 2001 Ford F350 and two Exmark Mowers; and

WHEREAS, the Village of Sherman advertised in a local publication the acceptance of sealed bids for such vehicles and equipment; and

WHEREAS, the Village of Sherman was presented sealed bids for said surplus vehicles and had a bid opening on Tuesday, January 16, 2024 at 10am at Sherman Village Hall; and




