#### Ordinance No. 20-21

### AN ORDINANCE AUTHORIZING THE PURCHASE OF CERTAIN LAND (SEMAN PROPERTY)

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SHERMAN, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The purchase of land from William and Mary Seman, as trustees, of the property at 7005 W. Outer Road in Sherman, consisting of approximately 6.41 acres (parcel numbers 07-30.0-101-005, 07-19.0-300-082, 06-24.0-400-012) is hereby approved. The intended use of the parcel is that of a public works headquarters. The consideration for the purchase is \$300,500 to be paid from the sewer funds as determined by the Village President. The Village President will determine a method to reimburse the sewer funds from other appropriate funds in the Village, and present that plan to the Board. The Village Administrator and Treasurer may then implement those actions.

SECTION 2: The President is authorized and directed to execute the contract, and the proper officers of the Village are directed to proceed to closing on the property.

**SECTION 3:** This Ordinance is effective immediately.
