ORDINANCE NO. 21-01

**AN ORDINANCE AUTHORIZING THE SALE OF CERTAIN VEHICLES OF
THE VILLAGE OF SHERMAN**

WHEREAS, the Village of Sherman, Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code, and

WHEREAS the corporate authorities of each municipality may pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities, with such fines or penalties as may be deemed proper; and

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/11-76-4, grants municipalities with a population less than 500,000, the authority to sell and dispose of personal property it determines, by a simple majority of the corporate authorities, to be no longer useful and necessary; and

WHEREAS, the Village of Sherman has five vehicles and equipment that are no longer of use or necessary for the Village operations notably a GMC Ambulance, Ford F350 with snow plow, End loader, Backhoe and Chevy Tahoe; and

WHEREAS The Village of Sherman advertised in a local publication the acceptance of sealed bids for five vehicles owned by the Village of Sherman; and

WHEREAS, the Village of Sherman was presented sealed bids for the five surplus vehicles and had a bid opening on Tuesday, January 12, 2021 at 10am at Sherman Village Hall; and

WHEREAS The President and Board of Trustees of the Village of Sherman find that the vehicles set forth in this Resolution are no longer useful or necessary and ownership shall be transferred as set forth herein.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Sherman, Sangamon County, Illinois, as follows:

Section 1. Recitals. The above recitals are incorporated herein by this reference as if specifically stated in full.

Section 2. Disposition of Property. The property listed above are hereby declared to be surplus property by the Village. In consideration of sealed bids opened on January 12th at 10am, the vehicles will be sold to the highest bidder of each one as listed on Appendix A.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Sherman prior to the effective date of this ordinance.

Section 5. Effectiveness. This ordinance is effective immediately.
