FOLLOWS:*

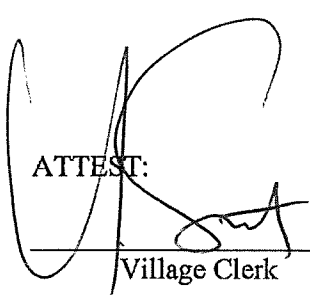
SECTION 1: The Village Board has reviewed and adopts the recommendation of the

with P.H. Broughton on behalf of the Village.

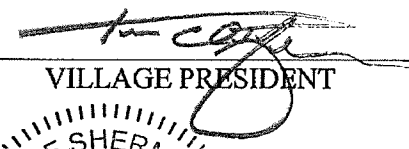
SECTION 3: This Ordinance is effective immediately.

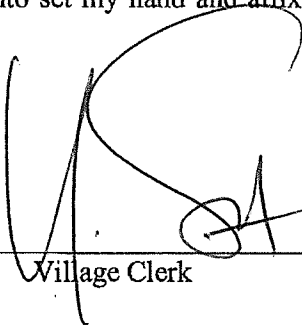
